ALL BOOTHS MUST BE OPEN AND OPERATING DURING ALL OF THE MARKET HOURS.

SPACE SIZE: Regular space size will be (8' Tables) - \$75.00 each for three days; \$65.00 each if payment is received before the deadline. Exhibitors must supply their own booth setups. Booths and aisles are to be kept clean and clear at all times.

SALES TAX LICENSE: Exhibitors are responsible for their own Michigan Sales Tax License or you will be issued the States Concessionaires Form C-5603. **(If you have a Sales Tax License, please send us a CURRENT copy when you apply for the show.)**

ADMISSION: Each Exhibitor will be issued (2) weekend admission passes. There are 40 acres of parking. All Exhibitors are required to park in the outer White Striped areas adjacent to the dock doors. No other charges are involved.

ELECTRICITY: Available at most spaces. If electricity is needed, please bring all necessary extension cords which must be 14-3 or heavier and power strips.

SECURITY: The building is securely-alarmed and additionally we have 24-hour outside security.

FOOD: There are several concession areas in the Market.

COPYRIGHT & TRADEMARK INFORMATION This is to inform all Exhibitors of our policy that prohibits sales, display or exhibition of merchandise which infringes upon any trademark, copyright, license of characters, logos, names or other symbols. ATTENTION: **THERE WILL BE NO DISMANTLING OF BOOTHS ALLOWED DURING REGULAR MARKET HOURS.**
